Hence radiation from the sun occurs in form of short waves and from earth it occurs in form of long waves. Atmosphere is transparent for solar radiation whereas it is like opaque for terrestrial radiation because some gases and water vapour absorb hence atmosphere becomes hotter from terrestrial radiation. Since atmosphere becomes hot due to terrestrial radiation hence it becomes hot from downward to upward.
