## **Terms & Conditions**

- i. The mentee should be from SC category and having valid caste certificate issued by the competent authority.
- ii. There will be no political or any other external pressure over the selection process. In case, such attempts are made to influence the selection process, then he/she may be debarred from the entire process.
- iii. Preference will be given to applicants belonging to lower income groups.
- iv. No application will be entertained after the prescribed deadline.
- v. Rules and regulations may undergo modification and the updated rules will be applicable and mandatory.
- vi. Once the selection process is completed, the mentee will be allotted for a training institute/coach/mentor and the mentee is instructed to adhere to all the instructions.
- vii. The mentee has to provide periodic updates and progress report of the training to BARTI in specified format. Non submission of update and progress report may invite disqualification.
- viii. Mentee shall participate in the mandated number of events as specified by BARTI.
- ix. If BARTI is organizing any cultural program in the field of Arts, then the selected mentee may be asked to participate and perform at the specified event.
